

#### **DIRECTOR'S DESK**





Europe, today, faces major challenges. With limited competitiveness, increasing defense requirements and expenditures, and the ongoing cost of living crisis and housing shortages, the continent must find ways to boost economic growth, address fiscal deficits, and avoid austerity policies that could undermine the social cohesion and values built over decades. Yet Europe is held back from achieving these goals by the fragmented policies of member states and by a lingering bureaucracy that often seems to operate detached from reality.

Significant agreements were signed during the conference between companies, Chamber members, and international partners, highlighting Greece's potential not only as a major energy transit hub for Europe but also as an energy producer, contributing substantially to the continent's energy security.

The arrival of the new US Ambassador to Greece adds further momentum to these efforts. A strong diplomatic presence will play a decisive role in deepening political and economic relations, supporting US investment, and promoting joint initiatives in energy, trade, and technology. Taken together, these developments create a unique opportunity to further upgrade business and trade relations between Greece and the United States.

Meanwhile, as Greece seeks to improve its competitiveness within the European Union, the country must move to strengthen the institutional framework, invest in infrastructure and innovation, and support key sectors such as energy, manufacturing, and technology, in order to continue attracting investment, foster a strong culture of entrepreneurship, and maintain its status as a reliable partner in the global market.



This initiative reaffirms the role of the American-Hellenic Chamber of Commerce as a catalyst for development and a bridge between culture and economic growth, contributing to the creation of a contemporary, outward-looking, and sustainable cultural ecosystem in Greece.

### AmCham Greece at P-TEC 2025

The American-Hellenic Chamber of Commerce was present at the Sixth Partnership for Transatlantic Energy Cooperation (P-TEC), which took place at Zappeion Megaron in Athens on November 6-7, 2025. Convened by the United States Department of Energy (USDOE), the Ministry of Environment and Energy of Greece, and the Atlantic Council

Global Energy Center, with the support of the American-Hellenic Chamber of Commerce, the event brought together energy ministers and delegations from Central and Eastern Europe to work together with USDOE, other US agencies, and the private sector to address key energy issues in the region and discuss energy security and affordability infrastructure projects, and investment opportunities.

AmCham Greece was represented at the event by Chamber President John D. Saracakis, who moderated the panel titled "Building the Backbone: Unlocking Capital for Global Energy Infrastructure," featuring Conor Coleman, Head of Investment at the US International Development Finance Corporation (DFC); Ioannis Tsakiris, Vice President of the European Investment Bank (EIB); Jeff Wilson, Senior Advisor for Energy Dominance, Office of the President and Chairman, at the Export-Import Bank of the United States (EXIM); and Derek Wong, Vice President of Government Relations and Public Affairs at Excelerate Energy.

The panel looked at innovative financing frameworks, multilateral partnerships, and institutional reforms with the potential to bridge the global energy infrastructure financing gap. By exploring strategies to reduce risk in investments, attract private capital, and build bankable projects, the discussion highlighted how stakeholders can lay the financial backbone of a secure and interconnected energy future.

Her legal accomplishments laid the foundation for a national media career, most notably as a co-host of The Five on Fox News, where she provided legal and political commentary on issues ranging from constitutional law to foreign affairs. Ambassador Guilfoyle is a best-selling author, writing Making the Case: How to Be Your Own Best Advocate, and the delightful children's book, The Princess and Her Pup.

Most recently she served as the founder and CEO of Polished Rice, Inc., and Managing Member of Metropolitan Medspa LLC and KGT Productions LLC. Beyond her legal and media work, Ambassador Guilfoyle has played a prominent role in national politics and public communications, having formerly served as a Senior Advisor to President Donald J. Trump and as National Chair, Trump Victory Finance Committee, Donald J. Trump for President, Inc. Originally from California, Ambassador Guilfoyle graduated magna cum laude with a Bachelor of Arts in Political Science from the University of California, Davis and earned her Juris Doctor degree from the University of San Francisco School of Law. She currently resides in Florida and has one son, Ronan Villency. Ambassador Guilfoyle is the 25th resident U.S. Ambassador to the Hellenic Republic and the first woman to hold the role.

# Investor Roundtable with Minister Pierrakakis

Greece is back, open for business, and an attractive and safe destination in an era of increased instability. This is the key message conveyed to investors and policymakers alike by Greece's most senior economic officials attending this year's Annual Meetings of the World Bank Group (WBG) and the International Monetary Fund (IMF) in Washington DC. On October 15, 2025, the American-Hellenic Chamber of Commerce USA was honored to organize an exclusive roundtable discussion with Kyriakos Pierrakakis, Minister of National Economy and Finance of the Hellenic Republic, hosted at Deloitte's Washington DC office by Managing Director Kostas Makrakis. Open remarks were delivered by John D. Saracakis, President of the American-Hellenic Chamber of Commerce, and Katerina Sokou, Executive Director of the US office, while the discussion was moderated by former US Treasury official and National Security Advisor Mark Medish.

In the Eastern Mediterranean region. Speakers at the event included Ekaterini Nassika, Ambassador of Greece to the United States; Matthew Kroenig, Vice President and Senior Director of the Atlantic Council's Scowcroft Center for Strategy and Security; and Jake Sotiriadis, nonresident senior fellow at the Atlantic Council's Scowcroft Center for Strategy and Security. In his welcoming remarks, AmCham Greece President John D. Saracakis noted the growing role of Greece in the defense tech ecosystem, while Christian Hadjiminas,

founder and CEO of Theon Group, spoke on the potential for enhancing industrial collaboration and integrating advanced technologies through transatlantic partnerships.

AmCham Greece was represented at this year's event by John D. Saracakis, President, and Katerina Sokou, Executive Director of the US office, who participated as speakers in the New Perspectives panel on Friday, October 10. In his address, President Saracakis spoke on the

# **Building Bridges** of Growth

Dr. Anthony Rodolakis, Executive Director of Tax and Economic Policy at Ostroff Associates, talks to Business Partners about building strong business partnerships between Greece and the United States, the importance of ethical leadership, and the promise of AmCham Greece's new office in Washington DC.

## Tell us a bit about your work at the intersection of economics, policy, and purpose.

My professional journey has always revolved around connecting analysis to action-turning data, ideas, and most importantly, relationships into meaningful economic outcomes. As Executive Director of Tax and Economic Policy at Ostroff Associates, I help bridge the gap between government policy and private enterprise, guiding companies, nonprofits, and institutions as they navigate complex fiscal and regulatory landscapes. My perspective has been shaped by seeing both sides of the policymaking table: how legislation becomes operational reality and how data-driven strategy can foster inclusive, sustainable growth.

At its core, my professional mission is about building bridges that endure—between analysis and action, between public purpose and private initiative, and between nations that share a belief in enterprise, education, and ethical leadership. Leadership, to me, is not about hierarchy—it's about stewardship, leading by example and never losing sight of the interests of your team. It means creating systems that outlast you, mentoring the next generation, and never losing sight of the ethical responsibility that comes with influence.

# Leadership is not about hierarchy—it's about stewardship

The challenges of our time—energy transition, digital transformation, and inclusive growth—require more than expertise; they demand trust, dialogue, and a renewed sense of common purpose. I am proud to contribute, in my small way, to that effort—helping ensure that both Greece and the United States continue to rise together.

#### What is the role of tax policy in bridging public policy and private enterprise?

Tax policy is not just a fiscal instrument. It is a signal of a society's values and priorities. When designed thoughtfully, it can catalyze investment, productivity, and innovation.

During my time in New York State government, I was privileged to help advance several initiatives that exemplify this synergy. The NYS Corporate Tax Reform of 2014–15, one of the most significant overhauls in state fiscal history, supported growth and enhanced New

York's competitiveness as an innovation hub. At the same time, small-business tax incentives for manufacturers and farmers helped stimulate capital formation and job growth across upstate regions. Complementing those reforms, various tax credit programs mobilized billions in private capital, demonstrating how smart fiscal design can marry public purpose with private initiative. Each of these efforts affirmed a core belief: Economic development succeeds when the public and private sectors share accountability. Policymakers provide the framework; businesses deliver the innovation and risk-taking that bring it to life.

In my current role, I see that same dynamic unfolding internationally. Strategic, evidence-based fiscal policy can help nations attract sustainable investment and accelerate their energy and digital transitions—when trust, transparency, and longterm planning align.

# In your work connecting Greek and US businesses, what have you found to be essential to effective and successful partnerships?

The Greek and US economies have complementary strengths that, when combined, create real potential for transatlantic innovation. Greece's position as a logistics and energy hub in Southeastern Europe, anchored by world-class shipping, renewables, and infrastructure projects, intersects naturally with the US's deep capital markets, technology expertise, and global financial networks. I've seen this synergy firsthand through initiatives in energy transition, shipping decarbonization, and carbon-market compliance, where analytical rigor and maritime experience come together to solve pressing global challenges.

Beyond analytics, I've focused on cultivating practical partnerships between Greek maritime enterprises and US companies across multiple sectors. I have been positively amazed by Greek firms' exceptional technical depth and operational experience; US partners contribute advanced analytics, financing models, and environmental-technology knowhow. Together, they form a natural alliance, helping fleets and logistics hubs modernize, comply with evolving EU and IMO standards, and unlock new opportunities in sustainable trade.

I'm also passionate about helping young Greek startup entrepreneurs in the education space. Supporting these initiatives means empowering educators to think entrepreneurially, access investment, and scale responsibly. Education and innovation are inseparable—and Greece's new generation of educators is proving that social purpose and economic dynamism can reinforce one another. But we need to help them. Public-private funding needs to be readily available to support those businesses in their early stages. This is a call for action for all. Whether in maritime services or

early-childhood education, these partnerships are built on trust and longterm vision. It's not merely about transactions—it's about creating enduring ecosystems where expertise, capital, and credibility flow freely in both directions.

Do you have any advice for young professionals or entrepreneurs looking to navigate global markets and foster meaningful cross-border partnerships? If there is one lesson my career has

Whether you are negotiating a policy reform, leading a team, or launching a venture, never sacrifice principle for expedience. Leadership is a daily practice of consistency: showing up prepared, owning your decisions, and respecting those whose perspectives differ from yours. And of course, always strive to learn and to grow. Even after decades in policy and

MBA with Shipping Management—because growth never stops. Humility and discipline are not opposites; they are the twin engines of progress.







# On the Precipice of Unprecedented Opportunities

Reflections on Greece's economic progress and its place in today's global landscape

A year after speaking at GES 2024, the Honorable Dina Titus, Member of Congress, First District of Nevada, shares her thoughts on the Greek Economic Summit and the country's economic trajectory and prospects.



Congresswoman Dina Titus has dedicated her entire professional life to education and public service.

She taught American and Nevada political science classes at the University of Nevada, Las Vegas for 34 years until her retirement in June 2011. A noted non-fiction writer, she is internationally known for her expertise in the history and policies related to nuclear power, weaponry, and waste. Titus represented the people of Senate District 7 in the Nevada Legislature for 20 years, serving as the Nevada Senate Democratic Minority Leader from 1993 to 2008. First elected to the US House of Representatives in November 2008, she has served the First Congressional District of Nevada for more than a decade and is the dean of Nevada's delegation. A persistent champion for average Nevadans, she has been rated one of the most effective Democratic members of the House of Representatives by the Center for Effective Lawmaking.

She serves as a member of the House Foreign Affairs Committee, where she brings common-sense expertise to international problems, and the House Transportation and Infrastructure Committee, where she serves as ranking member of a subcommittee that helps communities adapt to climate change and better respond to natural disasters.

Congresswoman Titus is a proud Greek American and serves as Vice Chair of the Hellenic Caucus in Congress, representing her heritage and fostering cooperation between the United States and Greece.

Dear Friends,

As a proud Greek-American legislator and member of the Congressional Hellenic Caucus, it is a pleasure to join you in marking the 36th Greek Economic Summit, the flagship forum of the American-Hellenic Chamber of Commerce. This gathering serves as the premier platform for strategic dialogue on global economic and geopolitical developments. As the international landscape continuously shifts and economic and security threats evolve, you have played a role in cementing Greece as a powerhouse in the Eastern Mediterranean region and beyond.

Greece's economic trajectory in the years following the financial crisis and the pandemic is nothing short of remarkable. Continuously outpacing many of its neighbors, Greece's sustained growth in recent years has led to all major credit ratings agencies returning Greece to an investment-grade sovereign debt credit rating. In fact, GDP growth this year is expected to top 2.3 percent. Not only has Athens implemented vast structural reforms as part of the IMF loan conditions, but it has exceeded expectations by adopting several new laws to reduce unemployment, boost growth, and adopt international best practices, including full digitalization of government services.

I have been particularly encouraged by seeing Greece evolve from a country beset by economic hardship to a regional hub in various sectors, none more strategic than energy. With major investments in natural gas infrastructure, electricity grid interconnections and upgrades, and renewable energy, Greece has quickly become a guarantor of energy security and diversification. The Floating Storage Regassification Unit (FSRU) in Alexandroupoli provides Greece sufficient import capacity to replace nearly 20-25 percent of Russian gas still consumed in southeast and central Europe with US LNG. Similarly, the implementation of the India-Middle East-Europe Corridor (IMEC) will sustain this growth. IMEC also promises to be a boon to US-Greece mutual interests and solidify the Eastern Mediterranean as the strategic link between East and West. The region is emerging as a central hub for energy and infrastructure connecting Europe, the Middle East, and India. By continuing investment in its port infrastructure and rail connectivity, Greece will solidify its status as Europe's gateway under this emerging framework.

While Greece's economic outlook is clearly very positive, I want to warn about the potential for a shrinking tourism economy. As Co-Chair of the Congressional Travel and Tourism Caucus and the Representative for Las Vegas, Nevada, I am keenly aware of the challenges a tourism-driven economy faces when there are shocks. Currently, in light of hefty tariffs President Trump has levied against the world and his rhetoric toward allies, Las Vegas is in the midst of a shrinking tourism sector; fewer people are visiting casinos, eating in restaurants, and attending shows in my district. While UN Tourism remains optimistic about the growth of global tourism through the end of this year, the larger economic picture is hazy, and multiple dynamics threaten the potential of tourism into 2026 and beyond. Greece, another economy that benefits from tourism, should take this into account and plan accordingly. Failing to do so could erase hard-won gains.

As a Senior Member of the House Foreign Affairs Committee, I have been focused on advancing the US-Greece relationship by fostering dialogue, increasing business ties, and creating opportunities for greater collaboration in regional security and energy interconnectedness. The Greek Economic Summit is a prime forum for accomplishing each of these goals. Greece faces unprecedented opportunities, and I stand ready to help seize those for the benefit of our two countries. So, please call on me anytime.

# ON TRACK TO A NEXT-GENERATION IAPR

Since stepping into his role as **Governor of Greece's Independent Authority for Public Revenue, George** Pitsilis has overseen an ambitious and radical transformation of the country's tax and customs administration, aiming to not only overhaul processes and operations but also fundamentally change the public's attitude toward tax compliance and the very way taxpayers interact with the IAPR. In this interview to Business Partners magazine. Pitsilis talks about his vision for the IAPR and discusses the impact of digitalization, the transformational potential of Al, and why people are, ultimately, an organization's most valuable asset.

Over the past years, the Independent Authority for Public Revenue (IAPR) has made remarkable progress toward a fundamental digital transformation and modernization of its systems and processes. What is your vision for a fully transformed IAPR?

A fully transformed, next-generation IAPR, as we envision it, is not a distant dream but the full maturation of our digital transformation. On the tax administration side, we are essentially talking about the implementation of the OECD's Tax Administration 3.0 model, where "tax just happens." At the core of this next phase is the utilization of the enormous volume of information we manage. This is where artificial intelligence and advanced analytical tools come in to help us detect complex forms of fraud in real time. This allows us to allocate our auditing resources in an extremely targeted way, based on algorithmic risk analysis. At the same time, the automation of even more complex procedures, such as mass data cross-referencing, is critical. In this way, we save valuable time, both for our employees and, crucially, for taxpayers, whether individuals or businesses. The digital recording of transactions and real-time information updates is, of course, an axis that is continuously strengthened.

An equally important goal is the completion of our organizational transformation. We want to move to a "one service, one system, one responsibility" model, meaning a tax authority that does not restrict and is not restricted by geographical limitations.

Finally, our next major challenge is the transition to a next-generation customs administration, based on organizational and digital transformation.

In the ongoing war on tax evasion, challenges are ever present, and tax evaders are constantly developing new tools and methods to bypass control mechanisms. A particularly significant challenge in today's economic environment is the emergence and rapid growth of new forms of wealth creation, such as cryptocurrencies, NFTs, and other digital assets. The nature of these assets and transactions necessitates the enhancement of our auditing capabilities. The IAPR is already prepared to address these new phenomena, with a continuous commitment to the development

and upgrading of digital and analytical control tools, ensuring that our mechanisms remain strong and effective against every new form of tax evasion.

# Beyond digital capabilities, trust and a culture of voluntary compliance are also essential to ensuring a fair and efficient tax system. What is the IAPR doing to enhance transparency and boost taxpayer confidence?

Technology is not an end in itself but a catalyst for rebuilding our relationship with society upon a foundation of trust. We are utilizing technology to create a tax administration that is not just smarter but also fairer, more efficient, and more human. In this context, our efforts to enhance voluntary compliance focus on two central axes: on simplification and digitalization of procedures and on justice and protection.

Technology is not an end in itself but a catalyst for rebuilding our relationship with society upon a foundation of trust When procedures are simple, digital, and do not require the taxpayer's physical presence, taxpayers' relationships with the administration automatically become more positive and transparent. That is why we invest in systems that allow taxpayers to easily find out what they must pay and why, without bureaucracy. Immediacy and simplicity are the most powerful tools for reinforcing trust. Simultaneously, we promote transparency in the design and implementation of our systems. For example, in our AI systems, we incorporate control over the

algorithmic decision and the explanation

of results, reducing the black box phenomenon and significantly enhancing the sense of justice.

## What steps is the IAPR taking to cultivate a stronger sense of tax responsibility, particularly among the younger generations and small businesses?

Developing a new tax culture is a longterm commitment that requires systematic effort. Fundamentally, it's a change in mindset. We seek to achieve this by continuously informing and familiarizing the public, so that individuals as well as businesses fully understand the procedures, reforms, and benefits of tax compliance.

Naturally, each audience requires a different approach. For the younger generations, who are digital natives, the approach is through technology. We are creating digital tools that make their lives easy, such as pre-filled forms

and digital services. The easier compliance is, the more self-evident it becomes.

For small businesses, the key is simplification. Tools such as myDATA, which automates their accounting monitoring, and myAADEapp, which allows for the immediate issuance of documents from a mobile phone, reduce the administrative burden. This promotes a mindset of shared contribution, as they feel that the system is working with them rather than against them.

At the same time, we are stepping up our public out-

reach efforts through social media, actions in schools, chambers of commerce, and professional associations across Greece. We want the public to get to know us, and we want to have the opportunity to engage in dialogue with them, to listen to their needs and concerns, and of course, to receive the relevant feedback. This isn't just about getting our message across but also about letting people know that we are here to support them.

# Big data and AI are changing how state agencies, including the IAPR, operate. How does this apply to tax and customs services?

Our AI expertise is something we are building day by day. Currently, we are integrating AI into three core functions: fraud and smuggling detection, data management and analysis (business intelligence and data analytics), and customer service and support.

We have established an operations room, which enables the real-time coordination of field audits, leveraging information to counter complex smuggling activities. We have also developed an input-output management information system that combines data from fuel station systems with our own to detect fuel non-compliance and fraud schemes. Meanwhile, we use machine-learning models, profiling techniques, and behavioral pattern recognition to predict tax violations.

Regarding data utilization, we apply big data mining and analysis methods to extract actionable insights that inform our strategic decisions. It's worth noting that the new Taxis system will integrate AI and data mining tools across all IAPR information systems.

Finally, in the area of customer service, we are developing chatbots utilizing large language models (LLMs), which will be able to answer questions and provide personalized guidance to citizens.

### In what ways is the IAPR working to ensure that, despite increasing automation, innovation within the organization remains human-centered?

The adoption of AI is not just a technological evolution; it is primarily a change in mindset. It liberates our employees from time-consuming and repetitive tasks, allowing them to focus on issues that require human judgment and strategic thinking. Our people are our most valuable asset, and that's why we invest in their education and the acquisition and development of new and important skills, such

as critical thinking and problemsolving. Furthermore, human supervision and human intervention at critical stages ensure that innovation maintains fairness and accessibility for everyone, preventing AI models from being swayed by potentially biased data. Within this framework, we are also launching new initiatives, such as the IAPR's upcoming AI Lab, which will form the core for the development of our new tools.

Organizations such as AmCham Greece play an important role in facilitating dialogue between the public and private sectors. How do you believe business associations like AmCham Greece can contribute to shaping a fair tax mentality and a constructive public debate on fiscal responsibility and reform?

Business associations such as the American-Hellenic Chamber of Commerce play a vital and multifaceted role, serv-

ing as a bridge between the public and private sectors. They provide us with valuable feedback on the impact of reforms on the real economy, allowing us to adjust our policies to be effective and business-friendly.

Through their various initiatives, they can actively contribute to cultivating a fair tax mentality and promoting voluntary compliance in the market. When the business community adopts and promotes high ethical and compliance standards, it sets the right example for the whole of society.

Furthermore, their contribution to shaping a constructive public debate on fiscal responsibility and reform is invaluable. Cooperation with organizations such as AmCham Greece ensures that our reforms are sustainable and based on a shared understanding of the economy's needs. After all, we actively participate in international reflection groups, such as the EU High-Level Reflection Group, and the international recognition of our work confirms that we are on the right track.



With this in mind, the American-Hellenic

Chamber of Commerce convened its 21st annual Athens Tax Forum under the theme "Changing Gears: Tax Policy at a Turning Point," inviting a host of distinguished speakers to add their voices to crucial discussions on key issues in taxation today. Held on November 3, 2025, at the Megaron, the Athens Concert Hall, Athens Tax Forum 2025 marked the first time that the forum was held under the auspices of the Independent Authority for Public Revenue (IAPR) and the Ministry of Economy and Finance, granted in recognition of the forum's invaluable contribution to shaping a constructive public debate on fiscal responsibility and tax reform.

Organized by the Chamber's Taxation

Committee, Athens Tax Forum 2025 lived up to its deserved reputation as a leading platform for government officials, policymakers, experts, and thought leaders from across the board to come together to share their insights, reflect on key trends and developments, and explore ways to contribute to a fair, stable, and predictable tax environment in Greece.

The forum kicked off with opening remarks by Elias Spirtounias, Executive Director of AmCham Greece, and a welcome address by Chamber President John D. Saracakis, who underlined the need for a tax system that promotes entrepreneurship and attracts investments, but also for tax policy that incorporates green

development and digital transition goals. The panel discussions that followed saw speakers explore a number of important topics including: how AI an digitalization are transforming tax operations, the evolving role of CFOs, the relationship between tax function and business strategy, the impact of taxes and tariffs in shaping a new global era, the role of tax strategy at the core of ESG, how technology and globalization are reshaping the profession, key changes toward modernizing tha national customs code, current tax law reforms and their implications, and the contribution of the European Court of Human Right to judicial protection.

The forum also included a series of oneon-one talks: on tax reform priorities, featuring Deputy Minister of Economy and Finance George Kotsiras; on transforming the IAPR for the modern era, featuring George Pitsilis, Governor of the IAPR; on how the EU is navigating global tax and regulatory shifts in an increasingly volatile landscape, featuring Vinod Kalloe, KPMG Tax Policy Leader for EMEA; on the evolving role of tax functions, featuring Chryssa Miliou, General Secretary of Tax Policy at the Ministry of Economy and Finance; on the digital transformation of the tax system, featuring Dimitrios Panozachos, CEO of Orthologismos; and on the impact of the One Big Beautiful Bill Act, featuring Watson M. McLeish, Senior Vice President for Tax Policy at the United States Chamber of Commerce.

The 21st Athens Tax Forum's proceedings concluded with a highly engaging discussion on fiscal policy featuring Minister of Economy and Finance Kyriakos Pierrakakis and AmCham Greece President John D. Saracakis, conferring with Ioannis Stavropoulos, Chair of the Chamber's Taxation Committee. During the discussion, Minister Pierrakakis talked about tax reforms as a driver for growth, outlining key benefits of changes to the tax system for taxpayers and businesses and stressing the need to change mindsets as well as processes. Pointing out that Greece is in the process of transforming its economic

model, Pierrakakis said that Greece now "checks all the boxes" and is poised to move forward and upward, while he also spoke about the geoeconomic benefits of the country's geopolitical advantage and pointed out that Greece remains an attractive investment destination for the United States. Following the discussion, the forum closed with a cocktail reception for participants and attendees. # **America's Timekeepers**

# How William Bond's Marine Chronometers Guided a New World

From the late 18th century, as ships sailed across vast oceans in pursuit of exploration and trade, the difference between safety and disaster often depended on a few seconds of time. Determining a ship's longitude required knowing the precise time at a fixed point—usually Greenwich, England—and comparing it with local time at sea. The device that made this possible was the marine chronometer, a masterpiece of mechanical precision that turned time itself into a navigational instrument.

Among the makers who mastered this delicate art, one American name stood out: William Bond & Son of Boston. Their chronometers were not just instruments; they were emblems of a young nation's growing command of science, engineering, and global reach, and their steady ticking signaled both craftsmanship and confidence, the essence of America's emerging technological identity.

### **Craftsmanship and Curiosity**

The story began in 1807, when English-born William Bond opened a small shop in Boston, establishing himself as a watch- and clockmaker. At a time when precision timekeeping was dominated by British makers, Bond's ambitions were remarkable. He soon partnered with his son, William Cranch Bond, an equally gifted craftsman whose interests extended into astronomy and physics, and soon their partnership gave the company its enduring name: William Bond & Son.

Their chronometers, regulators, and astronomical clocks were built with extraordinary attention to accuracy. Many of their marine chronometers incorporated fine English movements—by

Earnshaw, Frodsham, or Barraud—finished, adjusted, and tested by the Bonds in Boston. What distinguished their work, however, was not imitation but interpretation: a distinctive American insistence on practical reliability and empirical verification.

That same philosophy guided William Cranch Bond's later career as the first director of the Harvard College Observatory, where precision timekeeping

became the foundation for astronomical observation. There, the Bond family helped pioneer one of America's earliest electrical time distribution systems, synchronizing clocks through telegraphic signals—an innovation that foreshadowed today's networked timekeeping.

## Instruments of Navigation, Symbols of Trust

At sea, a Bond chronometer represented far more than a technical device. Enclosed in its gimballed brass case and mahogany box, it was an object of near-reverence. Captains relied on it to calculate their position, chart routes, and survive storms or fog. Every day, the officer of the watch wound it at precisely the same hour, ensuring continuity and care. To fail in its maintenance was unthinkable: A chronometer's reliability was synonymous with the crew's safety. William Bond & Son supplied chronometers to US Navy vessels, private shipping lines, and even scientific expeditions. Indeed, one of their instruments accompanied the United States Exploring Expedition of 1838-1842, contributing to early American efforts in hydrographic mapping. The chronometer thus became a quiet participant in the expansion of both commerce and knowledge, a companion to the compass, sextant, and chart in defining the contours of a new world.

### The Bond Legacy

The Bonds' achievement lay not only in their mechanical skill but in their understanding of time as an infrastructure of progress. They bridged the craft era of horology with the scientific age of standardization, laying the groundwork for a culture of precision that would later define American manufacturing, railroads, and communications.


Over the decades, as the firm evolved into William Bond & Sons and later William Bond & Co., their instruments found places not just on ships but in observatories, banks, and government institutions, where the accurate measurement of time underpinned trade, finance, and coordination. The Bond name became a benchmark for integrity: If a clock bore that inscription, it could be trusted.

This legacy extended into new domains. The synchronization of clocks across cities enabled railway timetables and telegraph networks. The precision culture pioneered by chronometer makers informed the industrial systems that would later define the American century. Every tick of a Bond chronometer was, in a sense, a rehearsal for the synchronized hum of modern infrastructure.

## Precision and Innovation: A Timeless Equation

The marine chronometer's purpose—to maintain unwavering accuracy in motion, amid salt air and shifting seas—embodies the same challenge that innovators face today: how to achieve stability within change. Whether in global logistics, digital communications, or data synchronization, the principles remain remarkably consistent.

Modern technologies such as GPS navigation and atomic clocks carry forward the chronometer's legacy on a new scale. Satellites orbiting Earth now provide the same essential function once performed by Bond's brass instruments-linking location to time with unerring precision. The transition from mechanical to digital timekeeping has altered the medium, but not the mission: the relentless pursuit of accuracy as a foundation of trust. In that sense, the Bond chronometer is not merely an antique. It is a reminder that innovation, at its best, is both measured and meaningful. The chronometer's beauty lies in its

balance—between art and science, movement and control, exploration and certainty. These same balances define the ethos of modern enterprise: the ability to navigate uncertainty through disciplined precision.

### A Living Heritage

Today, a few William Bond chronometers survive in museums and private collections, their brass still gleaming, their escapements still capable of beating with remarkable accuracy. They stand as artifacts of an age when craftsmanship, curiosity, and courage converged to shape the modern world.

For America, they symbolize something

enduring: the belief that progress requires both imagination and exactness and that innovation is not only about invention but about refinement. The Bonds were not just watchmakers; they were architects of time itself, translating the rhythm of a pendulum into the cadence of a nation's advance.

As we navigate the complexities of the 21st century, from global supply chains to space exploration, the story of William Bond & Son reminds us that every era's frontier begins with a simple question: What time is it?

And in answering it with precision, humanity charts its course forward once again.

# Shared Perspectives on Advancing Transatlantic Relations

## The ACE 2025 Best Practice Sharing Conference

AmCham representatives from across Europe and Eurasia came together in the historic city of Kotor in Montenegro for three days of engaging and forward-thinking dialogue on the critical issues shaping the future of business and investment, sharing insights, fostering collaboration, and exploring the evolving role of American Chambers of Commerce in today's global economy.

On October 8-10, 2025, the American Chamber of Commerce in Montenegro proudly hosted this year's AmChams in Europe (ACE) Best Practice Sharing Conference (BPSC), inviting AmCham representatives from across the continent to engage in spirited discussions, exchange ideas, and share best practices aimed at shaping the future of the AmChams in Europe network.

A total of 54 AmCham representatives from 29 countries in Europe and Eurasia came together in the breathtaking historic city of Kotor, on the Adriatic Sea, to promote cross-border partnerships and highlight the vital role of the transatlantic economy. With a focus on knowledge sharing, collaboration, and thought leadership, the event provided a dynamic platform for discussion of pivotal business issues, while delegates also took part in high-level meetings with local business and government leaders and enjoyed networking opportunities and local experiences.

## Operational Excellence and Strategic Collaboration

The conference's opening day kicked off with the Executive Committee Brunch

and Meeting and the official Conference Welcome, followed by a brainstorming segment focused on ACE's strategy for 2026-2030 and on the operational effectiveness of AmChams. Titled "Transatlantic Impact Group – Key Topics for 2026 and the Future of AmChams – National Perspectives," the segment saw participants working in two groups, one focusing on ACE strategy and the other on communication, membership and advocacy.

Guiding questions encouraged the exchange of practical solutions and success stories, and each round concluded with a reflection on key takeaways to foster shared learning among participants. The day ended with an exclusive gala dinner, a highlight of ACE 2025 BPSC, that underscored Montenegro's commitment to its EU accession goal, with hosts Sanja Ćalasan, President of AmCham Montenegro, and Marko Miročević, Executive Director of AmCham Montenegro, reaffirming the Chamber's dedication to supporting Montenegro's European path. of Montenegro. The discussion emphasized the value of such gatherings in strengthening transatlantic cooperation and promoting a shared European vision for prosperity and growth.

### **Benchmark and Insights**

Day two of the conference centered on this year's Benchmark Survey, featuring a presentation of the survey's findings followed by vivid discussions. Participants gained valuable insights and had the opportunity to evaluate individual and collective performance across the AmChams in Europe network. This was followed by breakout sessions that examined key topics such as digital transformation, European competitiveness, and synergies among AmChams. The sessions were expertly facilitated by members of the ACE Executive Committee Daniel Andrich, Peter Dahlen, Mila Malairau, and Asli Özelli, as well as ACE Chair Ajša Vodnik and Vice Chair Elias Spirtounias, Executive Director of AmCham Greece.

### **Leadership and Innovation**

The conference's third and final day brought together the CEOs of member AmChams for the annual ACE Board of Directors Meeting and further featured this year's Creative Network Awards, an annual celebration of top creative efforts and innovative initiatives by member AmChams under the #MadeByACE initiative. Presentations and voting were followed by an awards ceremony during which AmCham Slovenia was declared the winner for 2025, winning first place for its long-running AmCham YOUng Platform that empowers

young Slovenians to define and pursue their professional aspirations. The competition's runners up were AmCham Armenia and AmCham Slovakia.

The day further featured a guided tour of the Luštica Bay project as well as networking opportunities.

# Rescue, Rehabilitate, Protect

From urban expansion and pollution to habitat destruction and the devastating impact of the climate crisis, not least the increasing frequency and intensity of wildfires, Greece's rich natural heritage is under threat. Addressing these challenges and safeguarding the country's environment and biodiversity requires commitment, expertise, and collaboration across society. Here, Business Partners reached out to Maria Ganoti, Founder and Director of Anima – Hellenic Wildlife Care Association, one of the nonprofits at the heart of this effort, to learn more about Anima's wildlife rescue and rehabilitation work, the evolving challenges of wildlife conservation, and how individuals and businesses can contribute to protecting Greece's rich biodiversity.

Anima is among a handful of organizations leading wildlife rescue and rehabilitation efforts in Greece. Tell us a little about the scale of your work and how this has changed over the years.

Anima marked its 20th anniversary in 2025, and just between May and July this year, we received and cared for 6,163 wild animals. Admissions have surged dramatically over the past four years, forcing us to expand on every level—more space, more enclosures, more caretakers. A permanent wildlife veterinarian has joined our team, and we are now seeking resources to add a second one.

# Extreme heatwave and wildfire seasons in recent years have resulted in greater numbers of wild animals in need of rescue, treatment, and rehabilitation. How has Anima adapted its rescue protocols to deal with wildfire emergencies?

Heatwaves are now starting earlier, as soon as May, and lasting longer, colliding with the breeding season of many species. That's why we're seeing hundreds of chicks prematurely leap from their nests, especially on tall buildings, in a desperate attempt to escape the heat. Meanwhile, in drought-stricken areas such as Crete, dehydrated raptors are collapsing from exhaustion.

During wildfires, our volunteers rescue dozens of animals directly from the field, mainly tortoises and other reptiles. We've built a nationwide volunteer network trained with detailed first-aid guidelines. And specifically for fires, we've created a dedicated rescue unit, in partnership with the nonprofit volunteer organization Save Your Hood. This team goes into the fire zones, collects injured wildlife, and provides hydration and care even within the burned landscape.

# As a nonprofit that relies heavily on public support and volunteerism, how important is private-sector engagement to your mission?

Foundations remain key allies, and we've established close ties with some of those active in Greece. But the area of corporate responsibility is still underdeveloped for us—we are only now beginning to tap into it. We believe businesses will be the future of our financial

sustainability because their support usually comes as unrestricted funding. Unlike project-based grants, this kind of support covers essential operational costs, which are the hardest to secure.

# Anima cares for thousands of animals every year, and the numbers keep growing. How do you meet growing demands when working with just a small core team and limited resources?

Anima has managed to stay open 365 days a year, responding to calls at least 18 hours a day. We never set limits on the animals we accept. From sparrows to eagles, lizards and hedgehogs to foxes, jackals and even deer, we care for them all with the same dedication.

But this gets harder every year. Rising food and energy costs, combined with the public's own financial struggles, make it difficult to rely on large donations. That's why we need stronger state support and greater corporate involvement. What we do is not just wildlife rescue-it's a social service, giving thousands of people each year somewhere to turn when they find an injured animal. Beyond that, our work in biodiversity conservation is essential for both human survival and mental health. And through our scientific research, we contribute to the One Health framework, which is gaining momentum worldwide.

# What does true sustainability mean to you, and how can each of us, as individuals, businesses, or communities, actively contribute to protecting the environment and biodiversity in Greece?

Sustainability starts at an individual level—minimizing the footprint we leave on nature. That can mean how we manage our waste, how and where we build our homes, what chemicals we put on our fields, and even the food choices we make. But it doesn't end there. Everyone can actively support biodiversity conservation, whether by donating or volunteering. This is what allows organizations like ours to continue their vital, demanding work to protect Greece's natural heritage.



## ANIMA Hellenic Wildlife Care Association

Founded in 2005, Anima – Hellenic Wildlife Care Association is one of the key organizations dedicated to the care and rehabilitation of wildlife in Greece. Based in Attica, Anima takes in animals from all over the country, caring for more than 7,000 birds, mammals, and reptiles annually, including many rare and endangered species. The association's facilities include a first aid station in Kallithea, a wildlife care center in Saronikos, and a two-acre unit in the woods at Diomedes Botanical Garden in Haidari.

Over 20 years of working to rescue and rehabilitate wildlife and conserve biodiversity, Anima has cared for 83542 wild animals helped an impressive 372 species

# A Catalyst for Transformation

With research interests centered on developing novel analytical procedures for detecting and studying organic micropollutants in natural and engineered environments, Dr. Elia Psillakis, Professor of Aquatic Chemistry at the School of Chemical and Environmental Engineering of the Technical University of Crete, has contributed greatly to the scientific community. Widely published and cited, she has participated in major research projects and earned a host of international distinctions; most recently, she was selected as the recipient of the prestigious Robert Kellner Lecture Award by the Division of Analytical Chemistry of the European Chemical Society (DAC-EuChemS), with the award formally presented to her during the 22nd European Conference on Analytical Chemistry, Euroanalysis 2025, in Barcelona, where her lecture opened the conference. Here, Dr. Psillakis talks to Business Partners about finding inspiration, the importance of heartfelt mentoring, and blending interdisciplinary collaboration and global perspectives as a catalyst for transformation.

# What inspired your work in, and significant contributions to, the field of analytical chemistry?

Analytical chemistry is essential for monitoring and protecting the environment. However, there is a paradox at its core: The methods we use to study pollution often involve hazardous chemicals and generate waste that could harm the ecosystems we strive to protect. This contradiction has inspired a significant portion of my work, which aims to make analytical chemistry greener, more sustainable, and safer. We developed guidelines to reduce the environmental impact of resource-intensive stages and proposed metrics to quantify the greenness of analytical methods. Building on this, we introduced Circular Analytical Chemistry, a concept that seeks a closedloop, waste-free, and resource-efficient

sector. More recently, I presented the theoretical ideas related to sustainability in analytical chemistry, exploring what sustainability truly means and how it can be implemented within our field. The contradiction in analytical chemistry, however, not only inspired my efforts to make the field greener and more sustainable but also ignited my vision to fundamentally reimagine it. Analytical chemistry is a traditional and conservative field that advances through incremental technical improvements. My research is driven by the desire to transform it from a discipline that merely measures matter into one that serves as a beacon of environmental responsibility. This transformation demands disruptive and interdisciplinary efforts capable of catalyzing a cultural shift that redefines our tools, methods, and ultimately, our priorities.

## How did your experience as a Fulbright Scholar at the California Institute of Technology influence your academic path?

My Fulbright grant at Caltech was a transformative chapter that fundamentally reshaped my academic identity. Although I studied in both France and the UK, immersing myself in Caltech's unique ecosystem was a revelation. Its culture not only permitted interdisciplinary work; it demanded it. I was surrounded by brilliant minds who approached scientific problems as readily with a chemist as with a physicist or an engineer. Conversations were never confined by discipline, but were fluid, passionate debates about the core problem from every possible angle. In this environ-

ment, I learned to blend the theoretical depth from my European training with the holistic problemsolving approach of Caltech. This synthesis has since become the foundation of my scientific approach, influencing the way I design research projects, build teams, and mentor students. My work is a deliberate blend of interdisciplinary collaboration and a global perspective, because I learned that

solving our grand environmental challenges requires nothing less.

### How does analytical chemistry contribute to environmental protection and sustainability?

Analytical chemistry provides critical evidence for sustainability. We are the field that holds the magnifying glass to pollution, uncovering its sources, tracing its pathways, and quantifying its impact on our planet. The contributions of analytical chemistry are multifaceted. We develop the sophisticated tools needed to detect harmful contaminants, even at



the nanoscale, and track their fate in ecosystems. In a constantly changing world facing grand environmental challenges, this capability allows us to provide critical data that empower action at every level. We supply policymakers with evidence they need to create new or update existing regulations, support industries in minimizing their environmental footprint, and equip communities with the transparent information necessary to advocate for a healthier environment. In this way, analytical chemists act as essential, though often silent, guardians, collecting data and translating them into scientific knowledge and tangible action.

# You also teach and mentor young scientists. Tell us a little about this aspect of your work.

I have been fortunate in my career to have brilliant mentors from diverse



disciplines and backgrounds who have shaped me both as a researcher and as a person. Their guidance was always driven by a genuine care for my growth, not just my output. I strive to mentor in the same spirit, supporting and creating opportunities for young scientists who have that spark in their eyes, the curiosity, and drive that signal true potential. I collaborate with them as equals in research, use my experience to help them navigate their next steps, and build confidence within the complex academic system. Over the years, this group of young researchers has become a global community. Many of them are now emerging leaders, having secured prestigious positions and published research that challenges norms. I see their individual successes as part of a larger story: a self-perpetuating cycle of global mentorship and collaboration. For me, it is less about pride in their achievements and more about a profound sense of fulfillment in being able to give back what my mentors once offered me.

## What advice would you offer young Greek scientists aspiring to expand their horizons through international programs such as Fulbright?

Be bold and apply. It is natural to be daunted by the competitiveness, but it is a far greater loss when talented scientists self-select out. Keep in mind that evaluation committees look not

only at achievements but also at the potential, passion, and unique perspective you bring.

Prepare with purpose, but be open to transformation. Have a clear and detailed research plan, but don't let it become a boundary. Take a holistic view of the Fulbright experience and see it as a journey of integrated professional and personal growth. Strategize not only your research but also embrace your role as a scientific and cultural ambassador. Be intentional about building your network and reaching beyond your immediate lab to connect across departments and institutions.

Fulbright is not just a grant. It is the beginning of a lifelong membership in a global community. I experienced this firsthand. Whether at a conference or university visit, meeting a fellow Fulbrighter creates an immediate connection that transcends borders or disciplines. This community will become your permanent source of both professional collaboration and personal friendship.

Ultimately, your personal success in the Fulbright Program will be channeled back home, strengthening the entire Greek research ecosystem. And let your own journey serve as inspiration for the next generation, just as I hope my own journey has inspired you.

# Transfer Pricing as a Strategic Tool for Market Expansion

When it comes to strategic decisionmaking, planning and risk management, transfer pricing is a critical issue for domestic and multinational companies, as well as corporate tax executives.

For Greek taxpayers, transfer pricing has been mainly viewed as a compliance exercise: the preparation of transfer pricing documentation to support the pricing of intra-group arrangements as declared in the transfer pricing disclosure form filed with the tax return. However, transfer pricing goes beyond compliance. Backed by thoughtful analysis and agile expertise, it can become a useful tool for supporting and optimizing a group's market expansion.

Several Greece-headquartered groups are currently seeking to expand their operations in Europe, the United States of America, and the Middle East in order to explore market opportunities and potential synergies with other major players. These groups are considering various market, operational, and other issues related to their expansion into new markets. However, transfer pricing is not always a high priority, and this can result in lower efficiencies from a business and tax perspective.

Firstly, businesses with appropriate transfer pricing strategies can control profit allocation among group members. This allows businesses to align value creation with profitability and support the establishment of subsidiaries in new markets with lower margins to gain market share. Further to this, businesses can enhance

liquidity management with the use of an efficient transfer pricing framework by transferring funds to the entities that need support. This can be achieved through real time monitoring of the transfer prices, while any discrepancies can be identified and addressed quickly during the financial year. From this perspective, transfer pricing can also play a pivotal role in relation to the repatriation of profits from foreign subsidiaries in an efficient manner.

Lastly, groups with defendable transfer pricing policies can manage global tax burdens effectively while ensuring compliance with local tax and transfer pricing requirements.

# Art as a Path to Wellbeing

An important new initiative at the intersection of culture, health, and social innovation is exploring the role of art as a tool for enhancing mental health and promoting emotional wellbeing in people over 60.

Titled Well-Being for People 60+, the program is part of the Museum of Cycladic Art's commitment to social responsibility and is organized under the Ministry of Culture's national Art on Prescription initiative. It is taking place within the framework of the Greece 2.0 National Recovery and Resilience Plan with funding from the European Union's NextGenerationEU package and is being implemented by the Ministry's Directorate of Performing Arts and Cinema in collaboration with the University Research Institute of Mental Health, Neuroscience and Precision Medicine "Kostas Stefanis" (EPIPSY). With this move, Greece joins a broader international effort to integrate art and cultural participation into mental health strategies.

## A National Initiative with a Social Mission

Cultural prescription has gained growing recognition as an evidence-based approach for fostering wellbeing and promoting mental health beyond traditional clinical settings. In this context, the Art on Prescription initiative aims to develop structured collaborations between cultural institutions and individuals who could benefit from meaningful, guided engagement with the arts. Specifically, Well-Being for People 60+ addresses the clear social need to support older adults at a stage of life that's often marked by emotional challenges, shifting identities, and reduced social contact.

Older populations commonly experience increased stress, loneliness, and difficulty navigating transitions such as retirement, changes in physical ability, or the loss of loved ones. The program takes these realities as its starting point and seeks to offer targeted support through reflective, creative, and participatory activities.

## A Twelve-Week Journey Toward Connection and Resilience

Designed as a structured, three-month cycle, *Well-Being for People 60+* includes twelve weekly sessions held within the museum environment, where artworks serve as prompts for discussion and exploration. In total, the program comprises two three-month cycles—one running from September to December 2025 and another




from December 2025 to February 2026. Participation is free of charge.

Each session draws on experiential exercises, art therapy approaches, and guided observation of selected artifacts, while mental-health professionals facilitate conversations and activities that focus on themes such as emotional regulation, stress management, the importance of self-care, processing loss, and developing self-compassion. By examining artworks as mirrors of human experience and by engaging in creative expression, participants are encouraged to understand their emotions, reflect on personal narratives, and build supportive social bonds with others in the group. Importantly, the program does not require previous artistic experience. Its emphasis lies in the process: noticing, reflecting, sharing, and creating in a safe and structured environment.

### The Transformative Power of Art in Later Life

Research increasingly supports the idea that cultural participation can complement traditional mental health care, especially for older adults. Engaging with art has been shown to reduce anxiety, stimulate cognitive activity, encourage emotional expression, and counteract the effects of social isolation. Within a group setting, the benefits are amplified by regular interaction, routine, and shared purpose. For participants, the artworks become touchpoints for discussing universal experiences—change, vulnerability,





resilience, identity, and memory. Rather than focusing on artistic interpretation, the program uses these objects as catalysts for conversation and introspection. This approach allows participants to approach complex feelings indirectly, at a comfortable distance, while still gaining meaningful insight.

### **A Community-Oriented Approach to Wellbeing**

The program represents a shift toward understanding cultural spaces as resources for wellbeing and toward creating accessible interventions that reach beyond traditional healthcare environments. This aligns with evolving priorities in Greek cultural policy, which increasingly recognizes the role of culture in strengthening social cohesion and improving quality of life.

By participating in *Well-Being for People 60+*, older adults are not asked to become art enthusiasts. Instead, they are invited to use art as a tool, one that can help them navigate emotional complexity, rediscover connection, and cultivate resilience.

### A Model for the Future

As Greece and many other countries adapt to rapidly aging populations, programs such as *Well-Being for People 60+* offer new ways to support mental health in a sustainable, community-centered manner. If successful, the program could serve as a model for similar actions across the country, integrating cultural participation as a recognized component of preventive mental health care.

Above all, the initiative reaffirms something that has long been embedded in human experience: art provides more than aesthetic pleasure. It offers perspective, companionship, and a sense of meaning—qualities that become especially valuable in times of transition. In an era when many older adults face isolation and emotional strain, programs like this illuminate the potential of creativity and shared experience as pathways toward wellbeing.

# **Showcasing Greece's Regional Culture and Heritage**

In autumn 2025, the American-Hellenic Chamber of Commerce hosted a meeting with representatives from Greece's administrative regions to launch a strategic initiative promoting the country's regional culture and heritage. ## Tell us a little about the vision behind this ambitious initiative.

The Culture Committee of the American-Hellenic Chamber of Commerce works to develop connections between the cultural, business, academic, and political spheres and promote Greece's cultural wealth in ways that support economic growth.

In this context, the vision behind this initiative is to bridge the gap between culture and business and promote the culture and heritage of each of the country's thirteen Regions, in Greece as well as internationally. Regional cultural identities aren't limited to classical heritage and the plethora of ancient monuments and historical landmarks in each region; they also encompass traditional arts and crafts, gastronomy and culinary traditions, local products, religious traditions, health and wellness practices, and sports. It's all culture.

## What is the significance of linking culture with entrepreneurship?

Our members represent a variety of cultural industries—such as theater, cinema, visual arts, publishing, animation, and dance—as well as cultural institutions and businesses that value and support culture. We have considerable experience in bringing together parties across spheres and industries, and many of us have previously worked with regional authorities



on various programs, so we know how much local cultural institutions, businesses, and creators have to offer.

By facilitating collaboration between creators, institutions, and businesses, we help create synergies that enhance both cultural value and economic potential. By establishing these connections between culture and entrepreneurship, we can foster innovative partnerships, open new markets, and stimulate local economies, turning culture and heritage into drivers of sustainable development.

## What are the next steps forward for the initiative?

Following our first meeting with representatives from the various Regions earlier this month, we will continue to engage with each region to identify their unique strengths and challenges, cultural values, and opportunities, allowing each region's cultural identity to emerge as a unique asset for fostering local economic

growth and cultural diplomacy.

International visibility is key, so one of our first steps is the creation of Culture and Business Greece, a digital platform for mapping the cultural and creative products of Greece's thirteen Regions, streamlining international networking, and facilitating entry into key markets such as the United States.

Looking ahead, we plan to hold events dedicated to showcasing local culture and business opportunities, run strategic promotional campaigns in foreign media, and organize showcases and exhibitions abroad in collaboration with embassies, chambers of commerce, and cultural organizations. We will also provide advisory support to local startups and SMEs active in the creative and cultural industries.

# What does this initiative contribute to Greece's cultural ecosystem, and what is the Chamber's role in this?

AmCham Greece provides the strategic framework, international contacts, and organizational support essential for success, enabling us to leverage global networks, guide local entrepreneurs, and ensure that Greek culture is presented strategically to key audiences abroad.
