Nikolaos Bakatselos President American-Hellenic Chamber of Commerce

Nikolaos Bakatselos is the President & CEO of "Pyramis Metallourgia A.E." and "Pyramis Deutschland GmbH". Mr. Nikolaos Bakatselos was Member of the Board of Directors, and Deputy Managing Director, of "Northern Greece Publishing S.A.". He has held the position of Managing Director of "Imperium AEEX", and Member of the Board of Directors of "Egnatia Bank Securities S.A.". He was a Member of the Board of Directors of Attica Bank from February 2014 until June 2016. Mr. Bakatselos was a Member of the Steering Committee of the "International

Hellenic University" from 2006 until January 2014 and Member of the Board and President of the Northern Greece Committee of EEDE. He is Member of the Committee Support CERTH, Trustee of Anatolia College, Member of the Board and Member of the Steering Committee of SVE and Honorary Consul of Belgium for Northern Greece. After being a Member of the Board of Directors of the American – Hellenic Chamber of Commerce for several years, in June 2010 he was elected Vice President of AMCHAM and President of the Northern Greece Committee and since June 2019 he is the President of AMCHAM. In October 2019 he was elected as President of HEDNO by the General Assembly of HEDNO. Mr. Nikolaos Bakatselos holds a B.A. in Sociology from University of Reading and a MSc in Shipping, Trade and Finance from City University Business School.



Panagiotis Stampoulidis Secretary General of Commerce & Consumer Protection Ministry of Development & Investments

Panagiotis Stampoulidis is Secretary General of Commerce & Consumer Protection from 2019. From 2018 to 2019 he held the position of Chief Project Manager for Garnet SA. He has worked as Group Director Business Development for Megas Yeeros Group (2016-2017) and as Managing Director for C.M.F.O S.A. (Central Markets & Fishery Organization S.A.) (2011-2016). He was scientific consultant in more than a hundred (100) companies in the food industry from 2007 to 2011 and Internal Audit Manager, responsible to ensure health & safety

procedures for Kompatsiaris Bros (2005-2007). During his tenure in C.M.F.O. S.A., he implemented important actions and policies, including the following: Approval of the New Regulation commercialization of real estate CMFO SA., merging of 11 fish markets all over the country, merging of Central Market of Patras, creating the first logistic center for agricultural products in Greece, opening the "Consumer's Market", a new retail market in the Central Market of Athens, which includes stores selling products in lower price than the average retail price, oversubscription of 1.5 million deficit in the financial statements the financial year 2011, recording a positive sign of 23.000 Euros the financial year 2012 and 3 million Euros the financial year 2013, introducing the concept of a "Back Capital" (capital return to shareholders), resulting in the strengthening of government revenue at more than 10 million Euros, so CMFO SA became the first public company that returns 4.300.000 Euros to the basic shareholder (the Greek state) and also repaid 11 years earlier borrowing 4.302.226,00 Euros, modernization of Central Market of Athens and Fish Markets facilities, publishing the proclamation for creating the first wholesale fish market in Greece-in the Athens Central Market- by PPP process (total investment approx. 13 million Euros), publishing the proclamation for the parking management by PPP process (total investment approx. 7 million Euros), implementation of new computerized single system of economic and commercial management of the company. He holds an MBA in Human Resources Management from University of Wales, U.K. and a diploma in Animal Production from Technological Educational Institutional of Western Macedonia. Also, he has a certificate of Business Sustainability from University of Cambridge, U.K., a level 4 award in HACCP Management for Food Manufacturing, RSPH (Royal Society for Public Health) and an intermediate Certificate in Applied HACCP Principles, RSPH (Royal Society for Public Health). As a member of the G700, he was awarded with a distinction by the European Parliament in 2008 and he has project participation for the restructuring of the fishery sector in the Sultanate of Oman.

Vicky Grigoriadou is responsible for Nielsen's Business in Greece, holding the position of President and Managing Director of The Nielsen Company.
