Previously, Ambassador Pyatt was Principal Deputy Assistant Secretary of State in the Bureau of South and Central Asian Affairs from 2010-2013. He was Deputy Chief of Mission at the U.S. Mission to the International Organizations in Vienna, Austria from 2007 to 2010. He also served at the U.S. Embassy in New Delhi, India as Deputy Chief of Mission from 2006 to 2007 and as Political Counselor from 2002 to 2006. Ambassador Pyatt served as Economic Officer at the U.S. Consulate General in Hong Kong from 1999 to 2002 and as Principal Officer at the U.S. Consulate General in Lahore, Pakistan from 1997 to 1999. Since joining the Foreign Service in 1989, he has also served on the National Security Council staff, on the staff of Deputy Secretary Strobe Talbott and at posts in Honduras and India. Prior to joining the Foreign Service, he worked with The Inter-American Dialogue, a Washington-based think tank that brings together leading citizens of the Americas. Ambassador Pyatt grew up in La Jolla, California and holds a Master's degree in International Relations from Yale and B.A. in Political Science from the University of California, Irvine.

Dr. Pavlakis has extensive research and development experience in molecular biology, virology, and immunology. He has directed both basic research and clinical development projects based on his pioneering research achievements. He developed the first mammalian cell production of mature Human Growth Hormone, a successful biotechnology product. He developed codon/RNA optimization methods that have found wide applications in biotechnology, gene therapy protocols and many vaccines, including all Adenovirus vaccines and many nucleic acid vaccines. He developed DNA vaccines for HIV and showed they provide strong and long-lasting immunity. He developed lipid formulations for nucleic acid delivery in humans. He developed strong fluorescent GFP mutants that are in wide use in biology. His studies have provided new insights on the biology of several viruses; and have aided the development of diagnostic and therapeutic procedures. His work has also led to the development of innovative biotechnology drugs and gene therapy procedures. He presently works on cancer vaccines and immunotherapies as well as on HIV and coronavirus vaccines. He is a member of several professional societies, including the American Society for Clinical Investigation and the American Association of Physicians. He is a highly cited researcher, has authored more than 250 publications and is inventor of more than 70 US and International patents licensed to more than 30 pharmaceutical and biotechnology companies, including Novartis, Wyeth, Merck, Pfizer, Sigma. Due to his patented technologies and innovations, he has been elected Fellow of the National Academy of Inventors.

He was recently selected and appointed President of the National Medicines Agency (NTH). He is also Chairman of the Committee for the Negotiation of Drug Prices and Executive Member of the KESY. He has numerous scientific publications in reputable International and Greek journals and a significant number of papers in Greek and International Medical Conferences. 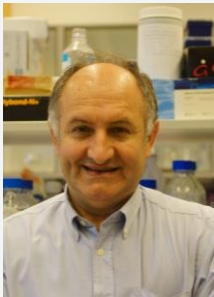

Dimitrios T. Boumpas, graduated from the Medical School of the University of Ioannina in 1983. Following a fellowship in Molecular Immunology at National Institutes of Health (NIH), Bethesda MD, he trained in Internal Medicine at Georgetown University, Washington DC and in Rheumatology-Clinical Immunology at ARB, NIAMS, NIH. Upon the completion of his training, he was appointed an Investigator at ARB, NIAMS, NIH where he served as Deputy and Acting Clinical Director. In 1999 he repatriated to the University of Crete to lead the Departments of Rheumatology, Clinical immunology and Allergy, and Internal Medicine. While in Crete, Professor Boumpas Directed the Graduate Program on the Molecular Basis of Human Diseases. In 2012 he joined the Medical School, University of Athens where he currently serves as the Chairman of the Fourth Department of Medicine at the “Attikon” University Hospital. He is also an Affiliated Member of the Institute for Biomedical Research of the Academy of Athens. Dr Boumpas primary clinical and research interests are in the areas of human autoimmunity with emphasis on systemic lupus erythematosus (SLE) and inflammatory arthritis. His work on the treatment of lupus nephritis has shaped immunosuppressive therapy for autoimmune rheumatic diseases internationally. He is also a leader in the transcriptomic analysis in human systemic autoimmunity. He has published over 250 peer-reviewed scientific papers and books chapters with over ISI 16.995 citations (h-index = 68) . His research was funded by both National (ΕΠΕΑΕΚ II, Πυθαγόρας I, II, Ηράκλειτος, Θαλής, Αριστεία) και European Union research funds (AUTOCURE FP-6; BTCURE, IMI, HORIZON 2020, ERC Advanced Grants). Dr. Boumpas is President of the Athens Medical Society and member of the Academia Europaea. He is also Chair r of European Task force on SLE that develops guidelines for the management and coordinates clinical trials and research on SLE and Associate Editor of Annals of Rheumatic Diseases. He is past-Chair of the European Research Council Panel for Advanced Grants on Diagnostics Tools), Therapies and Public Health (LS-7) and has served on the EU ESRI Committee for Translational Research Infrastructures.

He obtained his Medical Sciences Doctorate from NKUA, and did his residency in Medicine, NKUA, and Pediatrics, New York University, and his fellowship in Endocrinology, Metabolism and Diabetes at the National Institute of Child Health and Human Development (NICHD), National Institutes of Health (NIH), Bethesda, MD. He was Chief of the Pediatric and Reproductive Endocrinology Branch, NICHD, NIH, and subsequently Chairman, First Department of Pediatrics, NKUA, Athens, Greece, until 2018. Currently, he is Professor of Pediatrics and Endocrinology Emeritus, Holder, UNESCO Chair on Adolescent Health Care, Director of the University Research Institute on Maternal and Child Health and Precision Medicine at the NKUA, and Head of the Laboratory of Endocrinology and Metabolism at the Biomedical Research Foundation of the Academy of Athens. Professor Chrousos pioneered studies that elucidated the effects of stress on the organism at the behavioral, neuroendocrine, cellular and molecular levels and made fundamental contributions to the understanding, diagnosis and treatment of pituitary, adrenal and stress-related complex pathologies, i.e., major depression, obesity/metabolic syndrome, and autoimmune/inflammatory, reproductive and sleep disorders. He made seminal observations in the glucocorticoid signaling system of the cell and deciphered some of its key clinical implications. Professor Chrousos's work has been cited over 170,000 times (H-index 199) making him one of the top 200 cited authors (Google Scholar, June 2021) and a highly cited physician-scientist (ISI) in both Clinical Medicine and Biology and Biochemistry. He has received numerous major awards, including the Fred Conrad Koch Award, the highest honor of the US Endocrine Society, and the Bodossaki Aristeion Prize of the Bodossaki Foundation. He is a Doctor Honoris Causa of the Universities of Liege, Belgium, Universita Politecnica delle Marche, Ancona, Italy, and University of Patras, Greece, and an honorary professor of the Universities of Warwick, UK, St. Petersburg State Pediatric Medical University, Russia, Xi'an Medical University, China, and Democritean University of Thrace, Greece. He served as Board Member and President of the International Society of Neuroimmunomodulation, the European Society of Clinical Investigation and the European Society of Pediatric Endocrinology. He is an elected member of the American Society for Clinical Research, the Association of American Physicians, the European Academy of Sciences, Arts, and Letters Academia Europaea and the US National Academy of Medicine.

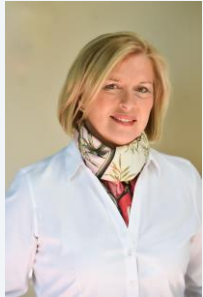

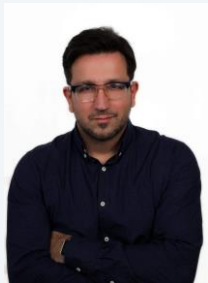
