Gianna Angelopoulos-Daskalaki is a lawyer, businesswoman, philanthropist, and Ambassador at-Large of the Greek State. She has been a member of the Hellenic Parliament and the President of the Athens 2004 Olympic Games Organizing Committee. Since 31 July 2019, she is the President of the "Greece 2021" Committee, the State institution established for the celebration of the bicentennial of the Greek Revolution of 1821. She studied law at the Aristotle University of Thessaloniki and practiced law for several years. In 1986 she started her public career, initially as a member of the municipal council in the Municipality of Athens and later as a member of the Hellenic Parliament, as elected MP in 1989 and 1990. After her marriage to businessman Theodoros Angelopoulos, she resigned from her seat in Parliament and devoted herself to her family, the family businesses, and social engagement. After securing the bid to host the 2004 Olympic Games, she was invited to organize the "Athens 2004" Olympic and Paralympic Games. After their successful conclusion, she described her experience in her book "My Greek Drama," which was published in May 2013 and was listed among the top ten best-selling books in the New York Times and the Wall Street Journal. Mrs. Angelopoulos is a supporter of educational initiatives and has an active philanthropic presence in projects in Greece and worldwide. She has served as Vice President of the Dean's Council of Harvard's Kennedy School of Governance since 1994. Among these initiatives are: the "Angelopoulos Global Public Leaders" Program at HKS, the interdisciplinary Angelopoulos Professorship in Public Health and International Development at Harvard, the Angelopoulos Foundation yearly scholarship program at the Clinton Global Initiative University, and the Gianna Angelopoulos Programme for Science Technology and Innovation (GAPSTI) at the University of Cambridge. It supports young scientists and graduate students with collaborations in the industrial sector and similar business enterprises. She was appointed Commander of the Order of Honor by the Hellenic Republic, Chevalier of the French Republic's National Order of the Legion of Honor by the French Republic, and recipient of the Gold Distinction by the International Olympic Committee. She is an Ambassador at-Large of the Hellenic Republic. She has been awarded a Ph.D. from the Department of Physical Education and Sport Science of the Aristotle University of Thessaloniki (1999) and the Gold Medal of the Hellenic Open University (2021). Since September 2021, she is the Honorary President of Greece-Israel Friendship Association. Mrs. Angelopoulos is a proud mother of three children and grandmother of three grandchildren.


