George James Tsunis presented his credentials to the President of the Hellenic Republic on May 10, 2022. He was nominated by President Biden and was confirmed by the U.S. Senate on March 10, 2022. Ambassador Tsunis is the proud Greek-American son of immigrants to the United States, with deep roots in the village of Platanos in the beautiful mountainous region of Nafpaktia. Growing up, his parents instilled in him the Hellenic ideals of καλοσύνη (goodness), αγάπη (love), and above all, φιλότιμο (the love of honor). He learned Greek as his first language. Deeply engaged with the Greek-American community, Ambassador Tsunis was a founding trustee of the Hellenic American Leadership Council, and is a trustee of the Hellenic Initiative among other roles. Prior to his nomination, Ambassador Tsunis was the Founder, Chairman and CEO of Chartwell Hotels, LLC. He served as Chairman of Battery Park City Authority. He was also a Trustee for the New York City Convention Development Corporation and the New York City Convention Operating Corporation and helped manage a 1.5 million square foot expansion of the New York Convention Center, transforming it into one of the world's most modern and beautiful convention centers. Ambassador Tsunis served as the chairman of the Nassau University Medical Center, a large public safety net hospital with a focus on providing care to vulnerable communities. Previously, Ambassador Tsunis was a Counsel and Partner (Attorney of Law), at Rivkin Radler LLP, Uniondale, NY, and Legislative Attorney, New York City Council. He served as Counsel for Dix Hills Water District, Dix Hills, NY and Town of Huntington Committee on Open Space Preservation, Huntington, NY. Ambassador Tsunis earned a B.A. from the New York University, New York, NY and a J.D. from St John's University of Law, Queens, NY. He was an Archon of the Ecumenical Patriarchate (Order of Saint Andrew), the highest ecclesiastical honor that can be bestowed upon a layman by the Greek Orthodox Archdiocese of America, and is the recipient of numerous awards including the Harry Chapin Humanitarian Award for Long Island Cares and the lifetime achievement award for civic engagement for Long Island Business News. Ambassador Tsunis is married and has three children.

Papagelopoulos, in the Standing Committee on Educational Affairs and in the Special Standing Committee on Parliamentary Ethics and Social Security. Andreas Loverdos is Parliamentary Candidate for the northern sector of the second Athens constituency, Member of the Hellenic Parliament 2000-2019, Parliamentary Spokesman KINIMA ALLAGIS-PASOK 2015-2019, Member of the National Council for Foreign Policy and Vice President of the Committee on Defense and Security of the NATO Parliamentary Assembly. He was born in Patras, Greece. He graduated from the law school of the Aristotle University of Thessaloniki in 1978. From 1978 until 1980, he fulfilled his obligatory military service in the Hellenic Air Force. In 1982, he completed postgraduate studies in European law at the Université libre de Bruxelles. During his studies, he served as vice-president of the Thessaloniki law students' union as well as president of the Greek students' association of Belgium. In 1986, Andreas Loverdos completed his PhD at the Aristotle University of Thessaloniki with the thesis *Terrorism and Political Crime: Study from the Perspective of Law*. In 1991, he undertook research at the London School of Economics on the function of government and in 1996 he researched the function of democratic constitutions at Boston University. He was a Lecturer in 1986, an Assistant Professor in 1992 and an Associate Professor in Public Law, Panton University of Athens in 1997. He is an author of numerous articles in legal research journals. He was a leading cadre of the Panhellenic Socialist Movement and he was first elected to the Hellenic Parliament in the 2000 legislative election. From 23 January 2002 until 10 March 2004 he served as Deputy Minister for Foreign Affairs. In October 2009, he was appointed Minister for Labour and Social Security. In September 2010, he was appointed Minister for Health and Social Solidarity. He held this post until 17 May 2012, when the coalition government of Lucas Papademos was replaced by the caretaker government of Panagiotis Pikrammenos. On December 3 2012, he announced the launch of a new political movement, the Radical Movement of Social Democratic Alliance (RIKSSY), and was subsequently expelled from the PASOK parliamentary group. A new political party, the Agreement for the New Greece, was formed by Loverdos and other members of RIKSSY on 15 April 2013. Andreas Loverdos returned to the government as Minister for Education and Religious Affairs on 10 June 2014, and to the PASOK parliamentary group on 22 August 2014. From May 2010 to December 2011, he served as President of OPAD (Health Care Organization for Public Servants), and from May 2011 to September 2012, as Vice President of EOPYY (National Organisation for Health Care Services Provision). From June 2010 to August 2013, he was a member of the National Ethics Committee for Clinical Trials and the Steering Committee for Rare Diseases. He has acted as a country expert on cancer at the OECD and Senior Associate Director at the Medical Technology Research Group of the LSE Enterprise. He has extensive research experience in Greece and abroad and he has acted as the Scientific Lead / Project Manager in 40 research projects. He has published 29 books and more than 300 chapters in books and papers in peer reviewed journals on health policy and economics, organization and administration of health services, economic inequalities, etc. He has participated as speaker in over 450 scientific conferences and he is acting as reviewer for international journals. He is Associate Editor at "BMC Public Health" (BioMed Central) and "Risk Management and Healthcare Policy" (Taylor & Francis) and has been Associate Editor at "Health Expectations" (Wiley).

## George Pavlakis

Chief, Human Retrovirus Section, Vaccine Branch, Center for Cancer Research  
National Cancer Institute, USA

Dr. Pavlakis received his M.D. from the University of Athens, Greece, and his Ph.D. from Syracuse University, New York. He moved to the National Cancer Institute in 1980 and is currently Chief of the Human Retrovirus Section. He has directed both basic research and clinical development projects based on his pioneering research achievements. Dr. Pavlakis has extensive research and development experience in molecular biology, virology, and immunology. He is credited with the first production of mature human hormones in mammalian cells by recombinant DNA technologies. This methodology is still in commercial production (human Growth Hormone). He continues this work by the development of new production methods and clinical application of heterodimeric IL-15 (hetIL-15), a cytokine presently in clinical trials for cancer immunotherapy. Dr. Pavlakis co-developed codon/RNA optimization methods that have found wide applications in biotechnology, gene therapy protocols and DNA vaccines. He developed DNA vaccines for HIV and showed they provide strong and long-lasting immunity. He developed strong fluorescent GFP mutants that are in wide use in biology. He studied the molecular biology, genetic organization and expression strategy of HIV and discovered important functions of its regulatory factors Tat and Rev. He described the first transcriptional activator on oncoretroviruses, the Tax protein of HTLV-I and the first posttranscriptional regulatory factor controlling mRNA export from the nucleus, the Rev protein of HIV-1. His studies have provided new insights on the biology of several viruses; and have aided the development of diagnostic and therapeutic procedures. His work has also led to the development of innovative biotechnology drugs and gene therapy procedures. Dr. Pavlakis is member of several professional societies, including the American Society for Clinical Investigation and the American Association of Physicians. He is a highly cited researcher, has authored more than 250 publications and is inventor of more than 70 US and International patents licensed to more than 30 pharmaceutical and biotechnology companies, including Novartis, Wyeth, Merck, Pfizer, Sigma. Due to his patented technologies and innovations, he has been elected Fellow of the National Academy of Inventors.

Prof. Artavanis-Tsakonas is a molecular biologist and developmental geneticist. He earned his MSc in Chemistry at the ETH in Zurich and his PhD in Molecular Biology from Cambridge University. After postdoctoral work at the Biozentrum in Basel and Stanford University, he joined the Yale faculty in 1982 and rose to Professor at the Department of Biology and Professor at the Department of Cell Biology at the Yale School of Medicine. Dr. Platanius leads the Robert H. Lurie Comprehensive Cancer Center of Northwestern University in Chicago, a founding member of National Comprehensive Cancer Centers Network (NCCN). He is the Jesse, Sara, Andrew, Abigail, Benjamin and Elizabeth Lurie Professor of Oncology and Professor of Medicine and Biochemistry and Molecular Genetics. Since Dr. Platanius became director in 2014, the Lurie Cancer Center (LCC) has experienced dramatic growth, with doubling of its NCI funding and the recruitment of over 160 new faculty members. Under his leadership, LCC received the highest rating in its history, an overall exceptional and a near-perfect score on the last CCSG renewal and is ranked number 6 in the USA in the last US News World Report rankings. Dr. Platanius was born and raised in Athens, Greece. He earned his medical degree and doctorate from the University of Patras Medical School, in Patras, Greece. He subsequently moved to the US and began his research career at the National Institutes of Health in Bethesda, Maryland, as a Fogarty research fellow studying the immune mechanisms of bone marrow failure syndromes. He subsequently moved to New York City where he completed his residency in Internal Medicine and eventually to Chicago where he completed his fellowship in Hematology-Oncology at the University of Chicago. He joined Northwestern in 2002, initially as Deputy Director and eventually as Director of the Lurie Cancer Center in 2014. Prior to joining Northwestern, he was Professor and Chief of the Division of Hematology Oncology at the University of Illinois at Chicago. Dr. Platanius is board certified in Internal Medicine and Medical Oncology, with clinical expertise in leukemia. Dr. Platanius' research work focuses on cytokine signaling pathways in malignant cells, with translational applications in leukemia and brain tumors. He has published more than 350 papers and his research has been continuously funded by the NCI for nearly 30 years. In addition to being the principal investigator of the largest institutional grant for cancer (CCSG) at Northwestern, he is currently the principal investigator of 4 NIH R01 grants and an I01 Merit Review. He has made significant contributions in the interferon and cytokine signaling field for 3 decades. His early work on interferon signaling, along with the work of others, led to discoveries that helped define the modern cancer immunotherapy field and resulted in clinical applications for the treatment of malignancies. He has been recognized with numerous awards, including the Seymour and Vivian Milstein Award for outstanding contributions in cytokine research and the UHVA Award for the Most Distinguished Greek American in the Field of Medicine. Dr. Platanius previously served as President of the International Cytokine and Interferon Society. He serves as Editor for several oncology and immunology journals and has been a chair or member of several study sections and site visit teams for the NIH, including more recently the NCI Subcommittee A for Cancer Centers. He has also served as chair or member of several grant panels for the US Department of Defense and the Department of Veterans Affairs.

## George Chrousos

Vice President, Hellenic Authority for Higher Education

Professor of Pediatrics and Endocrinology Emeritus, Director, University Research Institute of Maternal and Child Health and Precision Medicine, University of Athens, Holder, UNESCO Chair on Adolescent Health Care

Professor George Chrousos was born in Patras, Greece, in 1951. He completed his MD studies at the National and Kapodistrian University of Athens (NKUA) as the valedictorian of his class in 1975. He obtained his Medical Sciences Doctorate from NKUA, and did his residency in Medicine, NKUA, and Pediatrics, New York University, and his fellowship in Endocrinology, Metabolism and Diabetes at the National Institute of Child Health and Human Development (NICHD), National Institutes of Health (NIH), Bethesda, MD. He was Chief of the Pediatric and Reproductive Endocrinology Branch, NICHD, NIH, and subsequently Chairman, First Department of Pediatrics, NKUA, Athens, Greece, until 2018. Currently, he is Professor of Pediatrics and Endocrinology Emeritus, Holder, UNESCO Chair on Adolescent Health Care, Director of the University Research Institute on Maternal and Child Health and Precision Medicine at the NKUA, and Head of the Laboratory of Endocrinology and Metabolism at the Biomedical Research Foundation of the Academy of Athens. Professor Chrousos pioneered studies that elucidated the effects of stress on the organism at the behavioral, neuroendocrine, cellular and molecular levels and made fundamental contributions to the understanding, diagnosis and treatment of pituitary, adrenal and stress-related complex pathologies, i.e., major depression, obesity/metabolic syndrome, and autoimmune/inflammatory, reproductive and sleep disorders. He made seminal observations in the glucocorticoid signaling system of the cell and deciphered some of its key clinical implications. Professor Chrousos's work has been cited over 179,000 times (H-index >204) making him one of the top 100 cited authors (Google Scholar; research.com, Aug. 2022) and a highly cited physician-scientist (ISI) in both Clinical Medicine and Biology and Biochemistry. He has received numerous major awards, including the Fred Conrad Koch Award, the highest honor of the US Endocrine Society, and the Bodossaki Aristeion Prize of the Bodossaki Foundation. He is a Doctor Honoris Causa of the Universities of Liege, Belgium, Universita Politecnica delle Marche, Ancona, Italy, and University of Patras, Greece, and an honorary professor of the Universities of Warwick, UK, St. Petersburg State Pediatric Medical University, Russia, Xi'an Medical University, China, and Democritean University of Thrace, Greece. He served as Board Member and President of the International Society of Neuroimmunomodulation, the European Society of Clinical Investigation and the European Society of Pediatric Endocrinology. He is an elected member of the American Society for Clinical Research, the Association of American Physicians, the European Academy of Sciences, Arts, and Letters Academia Europaea and the US National Academy of Medicine.

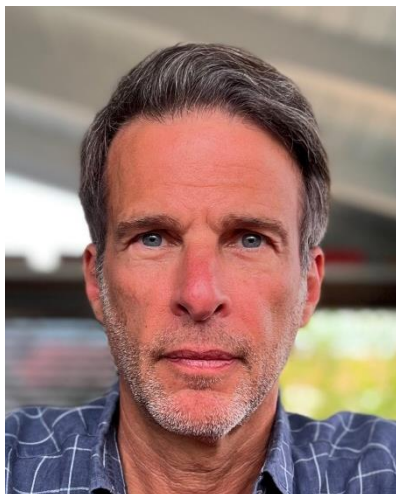

## Dr João Breda, MPH PhD MBA

Head of the Athens Quality of Care Office & Special Adviser for the Regional Director, WHO

Dr João Breda is the Head of the new Athens Quality of Care Office and Special Adviser of WHO Regional Director for the establishment of Sub-Regional Offices. Before moving to Greece João has been posted in WHO Senior Positions in Copenhagen (Denmark) for seven years and Moscow (Russian Federation) for four years. The newly established Athens Centre of Excellence aims to improve quality of care and patient safety at country level and focusing on reducing inequalities while promoting health innovation and leadership. João Breda is known for his teamwork, leadership skills (including great team player and high EQ and diversity promoter) and fund-raising ability which led to attract significant number of resources from major international donors. Until 2021 he Headed the WHO European Office for the Prevention and Control of Noncommunicable Diseases (NCD Office), which is an integral part of the WHO Regional Office for Europe. Launched in Moscow in 2014, the NCD Office marked an important milestone in the commitment made to combatting NCDs in the WHO European Region. Led by Dr Breda, the NCD Office provided support to 53 Member States in the WHO European Region based on population-level, targeted approaches to ensure a reduction in NCD risk, an overall decline in premature mortality. In 2019, the team he was leading was given an Award of Excellence announced by Dr Tedros Adhanom Ghebreyesus, WHO Director-General, which acknowledges the exceptional contribution to the Organization, tangible gains, and achievements. For eleven years Dr João Breda was Programme Manager for Nutrition, Physical Activity, and Obesity at the WHO Regional Office for Europe, responsible for the development and implementation and evaluation of the European Food and Nutrition Action Plan 2015-2020 and the Physical Activity Strategy for the WHO European Region 2016-2025. Dr. Breda was also the recipient of the Gold Medal for outstanding services in the field of Health granted by the Portuguese Ministry of Health in 2018. He also received more than 20 scientific and academic awards and/or distinctions notably the Honorary Professorship by the Medical Academy of Kazakhstan 2018, the Gerlev Award 2016 (Denmark) and gold medals for his work in obesity particularly in children by the Polish Institute of Maternal and Child Health (2021) and the Nutritionists Professional Order 2021 (Portugal). João Breda has published more than 250 original academic articles and reports, as well as more than 20 original books (including the best seller on infant nutrition in Portugal) and has more than 10000 citations. He is also considered to be among the top 1% researchers on obesity, globally. Before joining WHO, Dr Breda was the Portuguese focal point to WHO/Europe for alcohol, nutrition, and physical activity, and to the High-Level Group on Nutrition & Physical Activity and the European Platform on Diet, Nutrition and Physical Activity of the European Union. He was the first coordinator of the national platform against obesity under the Portuguese Ministry of Health. He worked as a public health official at the general Health Directorate of Health for many years. He was the Head of the Nutrition Department at Atlantic University in Lisbon as well as lecturer and researcher at the Agriculture University of Coimbra (ESAC), the University of the Algarve and the School of Hospitality and Culinary Arts in Coimbra. Dr João Breda is a PhD in Food Consumption & Nutritional Sciences by Porto University, a Master of Business Administration by the EU Business School in Barcelona, a Master's in public health and initially graduated in Nutritional Sciences. He is proficient in English, Spanish and Portuguese (mother tongue), intermediate knowledge of French and basic Russian.

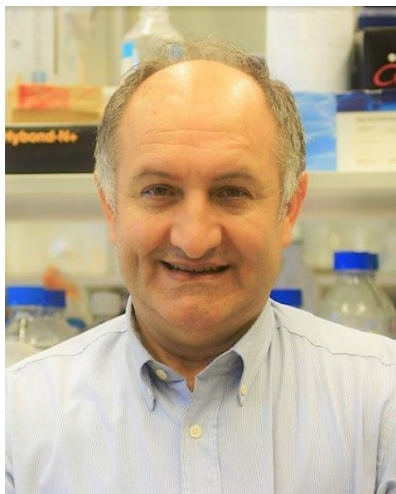

## Dimitrios Boumpas

Professor of Pathology - Rheumatology, Director of the Department of Pathology of the University of Athens, Head of the Rheumatology and Clinical Immunology Unit, "Attikon"

Dimitrios T. Boumpas, graduated from the Medical School of the University of Ioannina in 1983. Following a fellowship in Molecular Immunology at National Institutes of Health (NIH), Bethesda MD, he trained in Internal Medicine at Georgetown University, Washington DC and in Rheumatology-Clinical Immunology at ARB, NIAMS, NIH. Upon the completion of his training, he was appointed an Investigator at ARB, NIAMS, NIH where he served as Deputy and Acting Clinical Director. In 1999 he repatriated to the University of Crete to lead the Departments of Rheumatology, Clinical immunology and Allergy, and Internal Medicine. While in Crete, Professor Boumpas Directed the Graduate Program on the Molecular Basis of Human Diseases. In 2012 he joined the Medical School, University of Athens where he currently serves as the Chairman of the Fourth Department of Medicine at the "Attikon" University Hospital. He is also an Affiliated Member of the Institute for Biomedical Research of the Academy of Athens. Dr Boumpas primary clinical and research interests are in the areas of human autoimmunity with emphasis on systemic lupus erythematosus (SLE) and inflammatory arthritis. His work on the treatment of lupus nephritis has shaped immunosuppressive therapy for autoimmune rheumatic diseases internationally. He is also a leader in the transcriptomic analysis in human systemic autoimmunity. He has published over 250 peer-reviewed scientific papers and books chapters with over ISI 16.995 citations (h-index = 68). His research was funded by both National (ΕΠΕΑΕΚ II, Πυθαγόρας I, II, Ηράκλειτος, Θαλής, Αριστεία) και European Union research funds (AUTOCURE FP-6; BTCURE, IMI, HORIZON 2020, ERC Advanced Grants). Dr. Boumpas is President of the Athens Medical Society and member of the Academia Europaea. He is also Chair r of European Task force on SLE that develops guidelines for the management and coordinates clinical trials and research on SLE and Associate Editor of Annals of Rheumatic Diseases. He is past-Chair of the European Research Council Panel for Advanced Grants on Diagnostics Tools), Therapies and Public Health (LS-7) and has served on the EU ESRFI Committee for Translational Research Infrastructures.
