An award-winning public speaker, author, filmmaker, and philanthropist, Matthew regularly advises heads of governments and intelligence agencies. As the founder and CEO of The Mekong Club, Matthew is considered the leading catalyst of the anti-slavery movement in Asia's business sector by captains of industry. In 2017, Matthew received the prestigious "Asia Communicator of the Year Gold Award" for giving more than 1,100 presentations to 150,000 people including government leaders and the Vatican on the topic of modern slavery within a five-year period in different countries. Matthew has a unique and powerful speaking style that inspires people and helps them reach their fullest potential. Each year he is cited at least 40 times in the news media (CNN, Bloomberg, Reuters, Associated Press, the Financial Times, the Economist, etc.) and invited to speak at major international conferences around the world. He has managed and directed tens of millions of dollars to major humanitarian portfolios impacting millions of people for the World Bank, the U.S. State Department, and the United Nations. His work over the last 30 years of pioneering and managing international anti-human trafficking projects from Nepal, Bangladesh, Thailand and Hong Kong has given him access to many influential networks in different countries throughout the world. Matthew is the author of 14 books ranging from action novels, non-fiction accounts of his human rights work, to a book that outlines his unique philosophy of "time." A long-time supporter of film and the media arts, Matthew was an executive producer and advisor on four award-winning films, one of which was nominated for an Emmy and another executive produced by Emma Thompson. Matthew provides a range of inspirational keynote speeches to teach, mentor and motivate people from all walks of life to step up and take a stand in life.

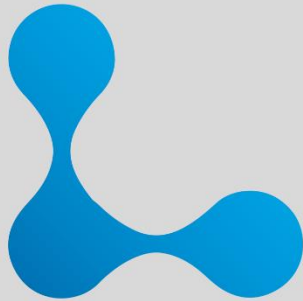

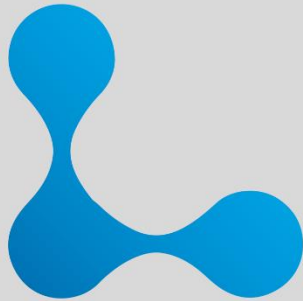

He is also leading the University of Pretoria in a collaborative project on “Climate Justice and Problems of Scale”, sponsored by the Consortium for Humanities Centres and Institutes (CHCI), involving the University of Texas at Austin, University of Sydney, Carnegie Mellon University, Arizona State University and American University in Beirut. He is the author of *Ngugi's Novels and African History: Narrating the Nation*. He has edited nine books and one anthology of African stories. His most recent edited volumes are *Ubuntu and the Reconstitution of Community* (Indiana UP, 2019) and *Environmental Humanities of Extraction in Africa: Poetics and politics of Extraction* (Routledge Publishers, 2023). Ogude is an “A” rated researcher by the National Research Foundation of South Africa.

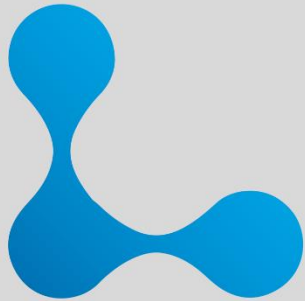

Constantina Skanavis, Professor of Environmental Communication, Education and Training, University of West Attica

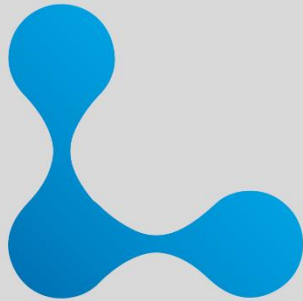

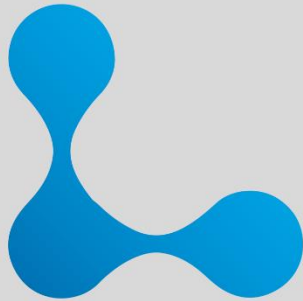

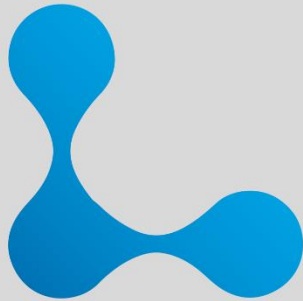

Sotirios Tsiodras is a Professor & chair of the 4th Dept. of Medicine at the National and Kapodistrian University of Athens Medical School. He completed post graduate training at Harvard Medical School in the USA and he is board certified in both Internal Medicine and Infectious Diseases by the American Board of Internal Medicine. He holds a MSc in the Medical Sciences from Harvard Medical School and is a graduate of the Clinical Investigator Training Program conducted by HMS and the MIT Division of Health Sciences and Technology both in Boston, MA. He has a PhD in Medicine from the National and Kapodistrian University of Athens Medical School. He is a member of the European CDC Advisory Forum since 2009, the current President of the Infectious Diseases Society of Greece and an Infectious Diseases Society of America fellow. He is the chair of the National committee of experts on Public Health, the chief scientific advisor of the Greek CDC and a member of the EU scientific advice platform on COVID-19. He is currently doing clinical and research work in internal medicine and infectious diseases at the Attikon University Hospital and the National & Kapodistrian Athens University Medical School in Athens, Greece.
