Dr. Christos Christou commenced his role as International President of Médecins Sans Frontières in the first week of September 2019. Before this, he held a number of roles in the field with MSF and with the Association in MSF Greece. Dr. Christou joined MSF in 2002, where his first assignment was in Greece as a field doctor, working with migrants and refugees, before working as a doctor in an HIV/AIDS project in Zambia in 2004 and 2005. After a break from field missions for a number of years while he trained as a surgeon, from 2013 he joined MSF missions in a number of conflict zones and insecure contexts, including South Sudan, Iraq and, most recently, Cameroon, as an emergency and trauma surgeon. Born in Trikala, a small town in central Greece, Dr. Christou graduated from Aristotle University's medical school in Thessaloniki, Greece, and has a PhD in Surgery from the Kapodistrian University of Athens. He holds a Masters in International Health - Health Crisis Management from the University of Athens and is member of its faculty. Dr. Christou later specialized in general and emergency surgery in the Surgical and Transplant Unit of Evangelismos Hospital in Athens. In 2013 he moved to London, working as a Senior Clinical Fellow in Colorectal surgery at King's College Hospital, and in 2018 became Consultant of Colorectal and Emergency Surgery at North Middlesex University Hospital. In 2018 he was awarded Fellow of the European Board of Surgery in Coloproctology. Dr. Christou was first General Secretary, then Vice-President and finally President of MSF Greece Board of Directors from 2005 until his election as International President in June 2019. In 2022, Dr. Christou was re-elected as International President for another three-year mandate.

Marianna was a Primary Investigator (2020-22) on a UKRI-funded COVID scheme project, 'Understanding the financial impact of COVID-19 on the UK care home sector – implications for businesses and the workforce', and on various research council-funded projects on whistleblowing. As result, the development and deployment of digital solutions with positive net carbon impact to be eligible for climate (sustainable, green) finance. He also works on the Digital Product Passport as introduced in the Eco-design for Sustainable Product Regulation and as explored in the EU project CIRPASS and CIRPASS 2. The aim is to accelerate the transition circular economy through digitally enabled sustainable business models and to reduce the administrative burden of (non-financial) reporting. Before 2017, Ilias has contributed to the EU Agenda of eHealth and ICT for Active and Healthy Ageing for over 20 years. Areas he pioneered include digitally supported Integrated Care, Virtual Physiological Human (Patient Digital Twin), Personal Health Systems and Electronic Health Records.

Ioannis Ioannou, Associate Professor of Strategy and Entrepreneurship, London Business School


Professor loannis loannou is a world-renowned expert in sustainability leadership, corporate responsibility, and ESG integration. His award-winning research on strategic sustainability integration and focus on investment markets has established him as a leading voice in the field. Professor Ioannou's research, published in top-tier journals including Strategic Management Journal, Academy of Management Review, and Management Science, provides critical insights into sustainable business model development. He is the most widely cited scholar of his graduating cohort and serves as Associate Editor of Strategic Management Journal and Management Science. His insights reach broader audiences through op-eds in Forbes, Financial Times, Les Echos, and Project Syndicate. An influential educator, Professor Ioannou designed and delivered a six-week online course on Sustainability Leadership and Corporate Responsibility that has enrolled over 1000 senior leaders and board members worldwide. His contributions to responsible business education earned him the Financial Times Responsible Business Education Award. Professor Ioannou actively engages with leading companies, boards, and executives on sustainability leadership transitions. His expertise has earned him positions on advisory boards including the Sustainability Advisory Panel of Merck KGaA, ESG Advisory Board of DWS Group, Advisory Board of Qurator, and as Strategic Advisor to LevelUp ESG. He serves as Senior Academic Advisor of Evolution Ltd. and member of the Advisory Council of the European Institute of Management and Finance (EIMF). He contributes to the FASTtrack to 2050 Taskforce by Accounting for Sustainability (A4S), focusing on behavioral shifts in finance professionals, and serves on the UN-supported Principles for Responsible Investment (PRI) Value Creation Working Group and Academic Advisory Panel, developing methodologies for quantifying sustainability outcomes in private markets. A sought-after speaker, Professor Ioannou delivers keynote speeches at high-profile events and industry conferences worldwide. His work has been featured in popular and managerial press outlets, and he is recognized as a top global influencer on responsible business and sustainability matters. He has been named a LinkedIn Top Voice, acknowledging his significant influence and thought leadership. Professor Ioannou holds a magna cum laude degree in Economics and Mathematics from Yale University and a Ph.D. in Business Economics from Harvard University and Harvard Business School. As Associate Professor with tenure at London Business School (LBS), he teaches on various degree programs and contributes to executive education programs on Responsible Business and Sustainability. Through his multifaceted approach, Professor Ioannou continues to shape sustainable business practices and responsible investing, bridging academic insights with real-world implementation.

She is the President of State Scholarships Foundation since 2024, and a member of the High-Level Advisory Committee to the Prime Minister for AI (2023-). She is the Editor-in-Chief of International Studies in the Philosophy of Science (2019-2025). She has served as Chair of the Graduate Program in History and Philosophy of Science and Technology (2022-2024), head of the Philosophy and Theory of Science and Technology Division of her Department (2017-2019), and the national representative to the Council of Europe Platform on Ethics, Transparency and Integrity in Education (2020-2024). In the summer of 2024, she was elected member of the Steering Committee of FISP (Fédération Internationale des Sociétés de Philosophie) for a five-year term. She was on the National Council of Research, Technology and Innovation (2019-2023), and as the national representative to the European Research Council (2021-2023). She has coordinated the project "University 2030" of the Bodossaki Foundation (2020-2021) and is a member of the board of the Lilian Voudouri Foundation (2023-). She is a founding member of the Hellenic Society of University Women and has been a member of its board (2011-2022). She regularly contributes to the press on philosophical issues of public interest and matters of academic policy and university reform.

Fanis Koutouvelis, CEO, Pandas

Fanis Koutouvelis is a serial tech entrepreneur. Recognized on Fortune's 40-Under-40 list for five consecutive years, Fanis has demonstrated a consistent ability to found, bootstrap, and scale technology companies. He studied Computer & Electrical Engineering at the University of Thessaly for four years but chose to drop out before graduating to start his first venture. In 2009, he launched Intale, in the ERP and Data Analytics sector for CPGs and Retail. Demonstrating his skill in bootstrapping, he grew the company to \$350,000 in sales and expanded to a team of seven full-time employees, all without seeking any funding. To further grow the business, he successfully raised \$8M in equity from investors in the US, UK, Greece and Germany, increasing the staff count to over 40 employees and driving the company towards profitability. Intale, developed the first web-based ERP and POS system in the SE European market. It became the market leader in the convenience retail segment, empowering over 2,000 businesses — from small independent retail stores to large chains like Philip Morris iQOS stores and Kiosky's. Annually, the Intale platform manages more than 200 million transactions per year and oversees over 1 billion Euros in transaction volume. In 2020, he founded Pandas, an innovative technology company specializing in instant appraisal and buyback for used mobile devices. Pandas has developed an Al solution that wirelessly identifies and evaluates any functioning mobile device seamlessly. This technology powers circular programs for telecom operators and retailers and is currently being utilized by partners like Deutsche Telekom (Europe) and Orange (Europe), SFR (France), Bouygues (France), Kingfisher (Australia), Etisalat (UAE), Du (UAE). Beyond his entrepreneurial ventures, Fanis has been a founding investor in a handful of companies, with the most notable being Zone01 — a full-time, 2-year coding school designed for career switchers and anyone looking to break into tech. Lastly, in 2016, he co-founded ReGeneration, an initiative addressing brain drain in Greece and assisting young professionals in securing their first jobs with multinational companies. This initiative has successfully launched the careers of over 2,000 voung professionals to date.
