



Papastratos, an affiliate of Philip Morris International (PMI), has been a leader in the production and commercialization of cigarettes and smoke-free tobacco products in Greece for the past nine decades. The company's history is closely linked to the evolution of industry, the country's economic development, and its contribution to society. In 2017, the company turned a new page in its long history by investing €300-million investment to transform its factory in Aspropyrgos into a facility exclusively producing heated tobacco sticks for IQOS, PMI's first innovative product which potentially holds a lower-risk compared to cigarettes.

In July 2020, the U.S. Food and Drug Administration (FDA) approved IQOS as a modified risk tobacco product, suitable for promoting public health. This new technology is now available in 95 countries, chosen by approximately 36.5 million adult smokers worldwide, including more than 750,000 in Greece.

In June 2021, on the occasion of Papastratos' 90th anniversary, the company announced its Sustainable Development Strategy for the next five years. At the same time, it revealed a new major investment in its Aspropyrgos factory, exceeding €200 million.

In February 2023, Papastratos announced another significant investment of €200 million, which led to the creation of 300 new jobs and strengthened the company's export activity, reaching an annual export value of €300 million.

With investments exceeding €700 million since 2017, Papastratos creates value for the company, its people, the environment, and society. Its extensive Corporate Social Responsibility program, repeated awards as a Top Employer, recognition as the Most Attractive Employer in Greece, and certification as the first company in Greece with Equal Pay Opportunities demonstrate that Sustainable Development is at the heart of Papastratos' business strategy.


